The insurer

This Banker's Blanket Bond policy is underwritten by CFC Underwriting Limited on behalf of certain Underwriters at Lloyd's and other insurers.

Significant features & benefits

A comprehensive crime policy designed to meet the insurance needs of smaller UK based regional banks, local branches of overseas banks, building societies and credit unions with deposits of up to £20 billion, including:

- any dishonest or fraudulent acts by employees, including the cost of any investigation or audit by the regulators arising therefrom
- property being lost or damaged by criminal means or otherwise
- property being lost or damaged by criminal means or otherwise while in transit in the care, custody or control of an authorised person, including transits carried out by a transport company
- your acceptance in good faith of any forged or fraudulently altered negotiable instrument, certificate of deposit, letter of credit, withdrawal order, receipt for the withdrawal of property or instruction or advice signed by a customer
- you in good faith:
 - Accepting any lost, stolen, forged or fraudulently altered original certified security, document of title, deed, mortgage or other instrument conveying title to real property certificate of origin or title, certificate of deposit, evidence of debt, guarantee or security agreement;
 - Guaranteeing or witnessing a signature relating to the transfer of ownership of any of the lost, stolen, forged or fraudulently altered documents stated above;
 - Accepting counterfeit money or any counterfeit mortgage;
- the fraudulent manipulation of your computer systems
- a telephone call where funds or property are transferred to an unintended third party
- processing any forged or counterfeit instruction sent by fax
- a letter or package listing the cheques and bankers drafts inside being lost in transit

Significant and unusual exclusions

Whilst we try to offer the broadest cover possible, we do not provide cover for certain situations. A summary of the significant and unusual exclusions that appear in the Policy are listed below. However, it is important to read the policy to see the full list of exclusions:

- Cash shortage due to human error
- Electronic communications sent by telex or automated clearing house
- Fire
- Fines or penalties
- Funds transfers that you fail to verify
- Insolvency
- Kidnap and ransom
- Any consequential loss arising out of a crime
- Property contained in a customers' safe deposit box
- Theft, forgery or other criminal act committed by any non-executive director or trustee

Limits of liability and deductible

The limits of liability and the deductibles are as specified in the Schedule.

Conditions

What we believe to be the most significant conditions are listed below, however all conditions in the policy are significant. It is important to read the policy and see the full list of conditions.

Right of cancellation

There is no cooling off period under this Policy but it may be cancelled with 60 days written notice by you.

Duration of the policy

Insurance policies normally run for a period of 12 months. We strongly urge you to review your Policy each year to ensure you have adequate cover in place.

Claims notification

Should you wish to notify a claim under this Policy, please contact the Claims Managers shown on your Policy Schedule. You must do this as soon as is reasonably practicable and no later than the end of any applicable extended reporting period.



Our regulatory status

CFC Underwriting Limited is authorised and regulated by the United Kingdom Financial Conduct Authority (FCA). CFC Underwriting Limited's Firm Reference Number at the FCA is 312848. We are covered by the Financial Services Compensation Scheme (FSCS). You may be entitled to compensation from the scheme if we cannot meet our obligations to you in respect of insurance policies that we have underwritten on behalf of insurers.

This depends on the type of business and the circumstances of the claim. In respect of general insurance business the FSCS will cover 90% of the claim, without any upper limit and for compulsory classes of insurance, the FSCS will cover 100% of the claim, without any upper limit.
