The insurer

This policy is underwritten by CFC Underwriting Limited on behalf of certain Underwriters at Lloyd's and other insurers.

- Claims arising out of any actual or alleged incidents occurring on or before the Retroactive Date
- Any matter known by you which you don't tell us about before we agree to cover you
- Breach of confidential sources

- Collection of private data without consent
- Unlawful surveillance
- Unsolicited communications
- Patent infringement
- License and royalty payments
- Liquidated damages, service credits and penalty clauses
- Any claim or part thereof that results in you being in a better financial position than you would have been if you had not committed an act, error or omission
- War and terrorism.

Limits of liability and deductibles

The limits of liability and deductibles are as specified in the Schedule.

Conditions

What we believe to be the most significant conditions are listed below, however all conditions in the policy are significant. It is important to read the policy and see the full list of conditions.

• What you must do in the event of a claim or cyber incident

You must notify us of any incident which may reasonably be expected to give rise to a claim as soon as you can (details how an incident should be notified to us and the subsequent actions you should take or should not take and that we may or may not take).

Right of cancellation

There is no cooling off period under this policy but it may be cancelled with 30 days written notice by either you or us.

Duration of the policy

Insurance policies normally run for a period of 12 months. We strongly urge you to review your policy each year to ensure you have adequate cover in place.

Claims notification

Should you wish to notify a claim under this Policy, please contact the Claims Managers shown on your Policy Schedule. You must do this as soon as is reasonably practicable and no later than the end of any applicable extended reporting period.

Our regulatory status

CFC Underwriting Limited is authorised and regulated by the United Kingdom Financial Conduct Authority (FCA). CFC Underwriting Limited's Firm Reference Number at the FCA is 312848. We are covered by the Financial Services Compensation Scheme (FSCS). You may be entitled to compensation from the scheme if we cannot meet our obligations to you in respect of insurance policies that we have underwritten on behalf of insurers.

This depends on the type of business and the circumstances of the claim. In respect of general insurance business the FSCS will cover 90% of the claim, without any upper limit and for compulsory classes of insurance, the FSCS will cover 100% of the claim, without any upper limit. Further information about compensation scheme arrangements is available from the FSCS.
